

Trade Compliance Post-Release Verifications

The CBSA manages compliance with the Tariff Treatment, Tariff Classification, Valuation, and Origin programs using the following two types of post-release verification processes:

1. Random Verifications
2. National Priorities

Random verifications

Random verifications are designed to measure compliance rates and revenue seepage and the results may be used for many purposes, e.g.,

- Risk assessment,
- Establishing client service activities,
- Revenue assessment, and
- Promoting voluntary compliance.

National priorities

National priorities (NPs) are determined through a risk-based, evergreen process; i.e., new NPs may be added throughout the fiscal year. NP verifications may also be carried over from previous years. The NPs currently being verified are:
